Trifecta Loyalty Configuration Incentive: **GET \$250 PER LOCATION!**

After **Club CITGO Rollback, Mobile Pay** and **FIS Premium Payback*** loyalty programs are configured and tested at qualifying locations. No paperwork necessary!

QUALIFICATIONS:

- ▶ Marketer-signed Loyalty Addendum on file
- ▶ Ensure locations meet the minimum requirements** listed below for Mobile Pay and FIS
- ▶ Register by November 25, 2021 in MarketNet® > Retail Operations > Loyalty Programs > Opt-In
- ▶ Complete the configuration by 20 days after sign up
- ▶ Complete a successful Club CITGO Rollback test transaction and validate mobile payment "heartbeat" by **December 15, 2021**

Once validated by CITGO, the Loyalty Program Trifecta Configuration Incentive will be scheduled for payout in December.

AFTER PROMOTION PERIOD

CITGO managed installations begins in January 2022

Technical configuration is \$250 per visit.

- ▶ CITGO will coordinate the configuration of the Loyalty Programs per the schedule provided to Marketers for locations that meet the minimum requirements.
- ▶ Technical configuration is \$250 per visit. Locations who do not allow the technician to complete the installation will be charged the full cost of the return visit.
- ▶ Locations that meet the minimum dispenser requirements but have not upgraded will be charged the \$250 installation fee upon successful Club CITGO Rollback test transaction and validation of a mobile payment "heartbeat".

QUALIFICATIONS:

- ▶ Marketer-signed Loyalty Addendum on file
- ▶ Locations that meet the minimum requirements listed below for Mobile Pay and FIS
- ▶ CITGO to Sign up locations 20 days prior to scheduling installation

*FIS Premium Payback Exception – Passport locations can only accommodate two loyalty programs. Locations with an existing loyalty program are required to install Club CITGO Rollback. In this instance, FIS Premium Payback will not be available.

**Minimum Requirements:

- Approved Firewall vendor - Acumera, Control Scan (Paysafe), Cyber or Mako
- Firewall upgraded to MNSP All-In-One Firewall - required for Mobile Pay and FIS Premium Payback
- Dispensers must have a screen, soft keys and pin pads
- Gilbarco Passport locations must be running the latest software version
 - CITGO Version 11 / POS Version 20.02 or 20.04
- Verifone Commander / RubyCI locations must be running the latest software version
 - CITGO Version 84 / VAPS 1.10.XX
